#### **Purpose of Visit:**

The purpose of the visit was to understand the functioning of Lok Adallat and to gain practical knowledge and experience in the field of alternative dispute resolution. The visit was to help the student understand the role of the Lok Adalat in dispensing speedy justice. This gave an opportunity to understand the actual need for co-ordination in the justice system.

52 students from ICFAI University Baddi and 4 faculty members visited the Judicial court kasauli, Solan, Himachal Pradesh, on May 13, 2023. The students were accompanied by Asst. Prof. Mamta Kumari, Asst. Prof. Champa Kaundal, Charu Sharma and Asst. Prof. Munish Thakur from the Baddi Campus of ICFAI University. The session judge of district court Solan gave permission for the visit, and Dr. Suresh Kumar, Head of the Faculty of Law at ICFAI University in Baddi, was able to get that permission.

The day started with a brief note given by the HOD of Faculty of Law Dr. Suresh Kumar to the students about the functioning of Lok Adalat. The college bus left from the ICFAI University campus at 7:30 a.m. and reached the Judicial court kasauli, Solan, Himachal Pradesh, at 12:00 p.m. The students visited the courtroom of Lok Adalat and observed the Court Proceedings. The students were also given the opportunity of interaction with Hon'ble Judges and eminent advocates, who enlightened the students with facts which pointed out the procedure and functioning of the Lok Adalat as well as explained the benefits of Lok Adalat. After observing the proceedings of the Lok Adalt, all the students proceeded towards the Mall Road, Kasauli, at 2:30 p.m., where they had their lunch. All the students were very excited to see the weather and explored the mall for at least 2 hours. At 4:00 p.m., the students were directed to gather at one Place at kasauli, from where they all proceeded to the college bus. All the students boarded the college bus at 4:30 p.m. and started their return trip back to ICFAI University, Baddi, and reached the university campus at 8:00 p.m, with this visit concluded.
