Subject: Adoption of UGC Suggestive Parameters for Selection of Peer-Reviewed Journals.

In continuation of the directions issued by the University Grants Commission (UGC), it is hereby notified for the information of all faculty members, research scholars, and students that the UGC-CARE List of Journals has been discontinued with effect from February 11, 2025 (Annexure-I).

Subsequently, the UGC, vide its Public Notice dated July 16, 2025 (Annexure-II), has issued "Suggestive Parameters for Selection of Peer-Reviewed Journals", thereby advising Higher Education Institutions (HEIs) to adopt institutional mechanisms for ensuring the quality, credibility, and ethical standards of research publications.

1. Adoption at Institutional Level

The University hereby adopts the UGC Suggestive Parameters for Selection of Peer-Reviewed Journals for all future research publications authored by faculty members, research scholars, and students.

2. Applicability

This notification shall be applicable to:

- All faculty members.
- Research scholars (Ph.D./PG).
- Students involved in research publication.

3. Compliance Requirement

All authors shall ensure due diligence while selecting journals and shall adhere to the parameters prescribed by UGC. Head of Departments are advised to sensitize faculty members and research scholars regarding ethical and responsible research publishing practices.

4. Institutional Oversight and Periodic Review

To ensure effective implementation of the UGC suggestive parameters and to uphold the quality, integrity, and credibility of research publications, the University has constituted an Internal Review Committee on Journal Quality and Research Standards (Annexure-III).

The Committee shall be responsible for the following:

- To periodically review the journal selection practices adopted by faculty members and research scholars.
- To assess compliance with the UGC suggestive parameters for identifying quality peer-reviewed journals.
- To recommend appropriate updates, corrective actions, or improvements, wherever required, in order to strengthen ethical, transparent, and quality-driven research publishing practices within the University.
- The Dean / Dean In-charge of the respective Faculty, in coordination with the Research Coordinator of the concerned Department, shall verify that the published research work complies with the prescribed UGC suggestive parameters and institutional guidelines.

The Committee shall also review the process from time to time to ensure that institutional practices remain aligned with evolving UGC guidelines and best academic standards.

5. Non-Consideration of Non-Compliant Journals

Any journal that does not satisfy the UGC suggestive parameters for selection of peer-reviewed journals (as detailed in Annexure-IV) and/or is identified by the University or any statutory or regulatory authority as non-transparent, unethical, or non-compliant, shall not be considered for any academic purpose within The ICFAI University, Himachal Pradesh.

Such academic purposes shall include, but shall not be limited to:

- Ph.D. work and thesis submission requirements.
- Faculty appraisal, Career Advancement Scheme (CAS) and promotions.
- Research incentives, grants or institutional awards.



Faculty members and research scholars are advised to consider the prescribed parameters while selecting journals for publication. These parameters are intended to ensure ethical practices, transparency, and overall quality of research outputs.
